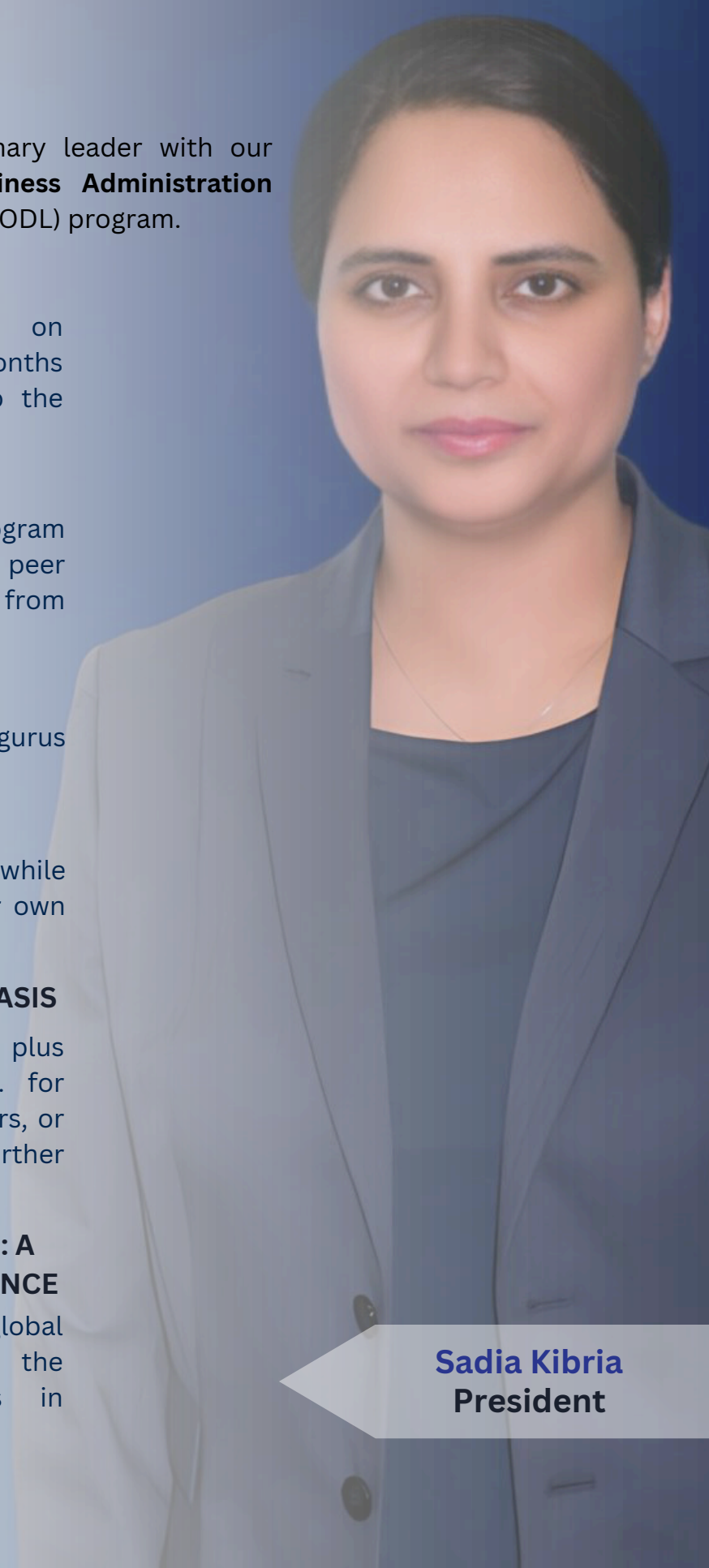

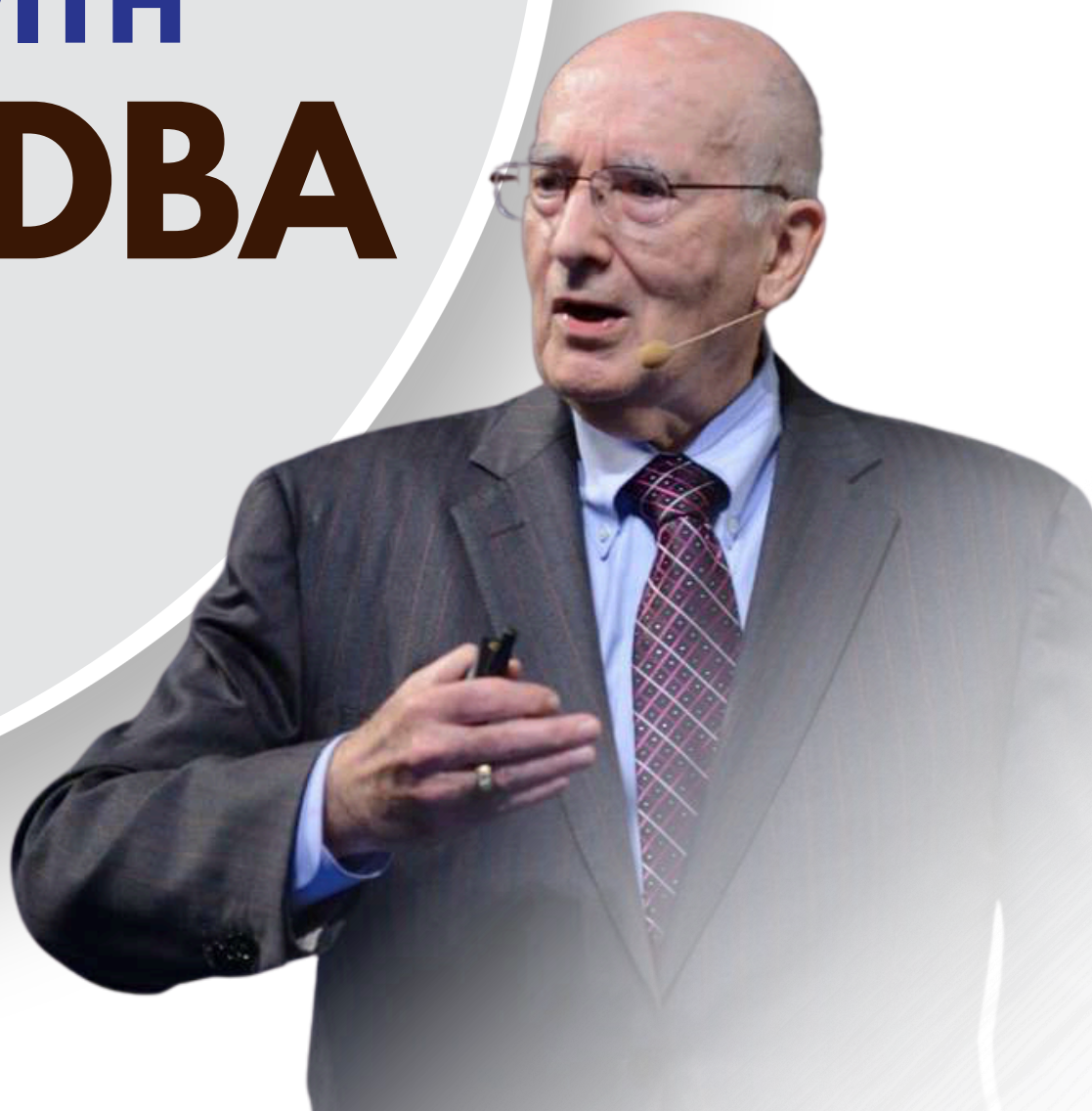

Minimum IELTS overall band score of 6.0 or its equivalent.
